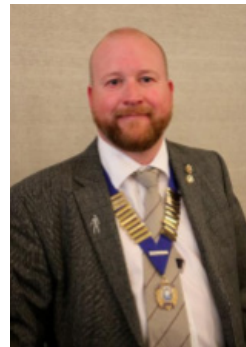

IMPORTANT NOTICE



Mandatory Submission of Advance Cargo Manifest with effect from 1st July 2019 (Chittagong Port)

In accordance with World Trade Organization's Trade Facilitation Agreement (TFA), National Board of Revenue (NBR), Bangladesh is going to implement Pre-Arrival Processing (PAP) from 1st July 2019. Customs House Chittagong has issued a notice (circular) to all concerned to follow the mentioned timeline.

Effective 1st July, all shipping lines/Freight Forwarders must submit the complete "Electronic Cargo Manifest (Import General Manifest-IGM)" 24 hours before vessel sailing from last port of call.

To ensure correct & on-time manifest submission, we kindly request for the full set of documents to be provided 3 days prior to vessel departure from last calling ports.



IMPORTANT NOTICE

Implementation of Sea Cargo Manifest & Transshipment Regulations (SCMT) with effect from 1st August 2019 (India)

The Government of India (Central Board of Indirect Taxes and Custom – CBIT) vide notification dated 27th February 2019 have announced Sea Cargo Manifest and Transshipment Regulation (SCMT) 2019, which shall be effective from 1st August 2019. This new regulation made it compulsory for Shipping lines, exporters, importers to adhere to the defined timelines for the Cargo Manifestation for all cargo arriving, departing and transshipping via India ports.

Under this regulation, customers are required to submit Departure Manifest electronically 5 days before vessel sailing from the Indian Port of call.

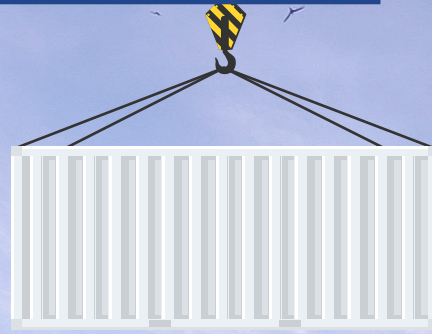
The new mandatory data elements required are:

1. 6 Digits HS (Harmonized) Code
2. IEC (Import and Export Code) of consignee
3. Pan Number of Notify Party (If Notify Party is from India)
4. Invoice Value

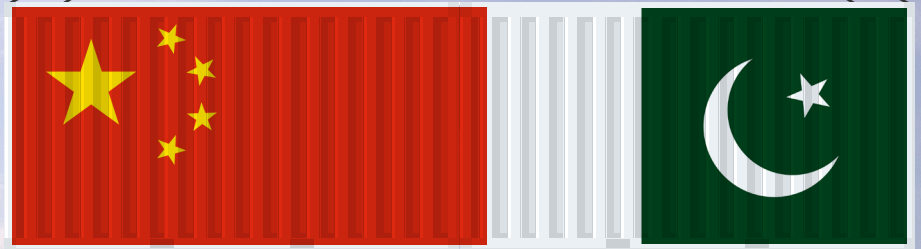
