NOTICE: ADVANCED CARGO INFORMATION DECLARATION (ACID) FOR CARGO TO EGYPTIAN PORTS



Under the Custom Law 207/2020, Egyptian authorities has implemented new Advance Cargo Information regulations. The regulation's effective date will commence on 1st July 2021. It will becomes mandatory to indicate the shipments identity number (ACID number) for all cargo destined to Egypt.

The ACID system has been implemented with the aim to make available to the Egyptian Customs the shipments details before departure from the country of origin. The code shall be requested from the receiver and notified to the shipper who is obliged to report it on all documents covering the shipment, included BLS and cargo manifests.

Accordingly, all shipping details as mentioned in the manifest should be dictated by the shipper and confirmed by the Consignee during the booking time.



NOTICE: ACID (ADVANCED CARGO INFORMATION DECLARATION) FOR CARGO TO EGYPTIAN PORTS



Importer has to advise ACID number on booking level as to be mentioned on all shipping documents thereafter - ACID Number = a 19 digits Number identifying the ACI shipment

All shipping documents should mention the ACID number for cargo to Egypt & identification numbers (TAX ID) of all parties on the BL.





10-digit HS code required to be manifested

Exporter Registration Number = a 17 alphanumeric number





Egyptian Importer VAT Number (TAX ID NUM.) = a 9 digits number identifying all companies registered in Egypt

The importer or agent shall commit to present the cargo documents to the authority before shipping them to the country for annotation with a preliminary customs registration number.

The importer or his agent shall further commit to notify the shipper with this number for registration of same on the cargo shipping documents.

In the absence of such indication or in case of wrong code, or in case the data does not match with what stated from the receiver to the Customs, the goods in subject will not be discharged and the Shipping Company will be obliged to return it to the POL.
